Proposed Budget for 2021-2022 was reviewed. Total Budgeted expense is \$2912. Motion was made to approve the Proposed Budget by Scott Fisher, second by Ann Kalgren. Motion passed unanimously.

Membership Report

A membership report was given by Linda Esser.

Current RLIA membership count is 61 members for the new year. Total number of residents on Round Lake is 268. Membership has been increasing, Linda will continue to send out email blast to membership regarding annual meeting. The membership form will continue to be published in the RLIA newsletter.

Elect Officers

President - Terry Waagmeester was nominated to serve as the next RLIA President. A motion was made by Scott Fisher to elect Terry Waagmeester as President to replace Mark Parrish, second by Luke Vander Aarde. Motion passed unanimously. Mark Parrish will review with Terry Waagmeester the President's duties, including writing the letter that will go out to all who have not paid dues. Treasurer - Linda Esser will continue to act as Treasurer. A motion was made by Scott Fisher to elect Linda as Treasurer, second by Ann Kalgren. Motion passed unanimously. Mike Zager has offered to assist Linda with treasurer' duties for the duration of the 2022 fiscal year. He intends to then volunteer as next Treasurer. Secretary - Ann Kalgren offered to continue serving as Secretary. A motion was made by Linda Esser to elect Ann Kalgren as Secretary, second by Scott Fisher. Motion passed unanimously.

New Business

Sale Around Round - due to the County Rd 115 road construction project, the "Sale Around Round" event will not be held in 2023 and 2024.
